THIS ASSIGNMENT OF DECLARANT RIGHTS (this "Assignment") is executed as of the day of October, 2002, by BANK OF AMERICA, N.A., AS TRUSTEE FOR THE NCNB REAL ESTATE FUND ("Bank of America"), in favor of BROOKFIELD SOUTH ASSOCIATES, LLC, a North Carolina limited liability company ("Brookfield").

WITNESSETH:

WHEREAS, Bank of America is the "Declarant" under that certain Declaration of Easements, Covenants, Conditions and Restrictions for Brookfield South recorded in Deed Book 1539 at Page 887 in the Greenville County, South Carolina, R.M.C. Office (the "Greenville County Registry"), as amended by that certain Amendment to Declaration of Easements, Covenants, Conditions and Restrictions for Brookfield South recorded in Deed Book 1539 at Page 931 in the Greenville County Registry, and as further amended by that certain Second Amendment to Declaration of Easements, Covenants, Conditions and Restrictions for Brookfield South recorded in Deed Book 1670 at Page 394 in the Greenville County Registry, and as further amended by that certain Third Amendment to Declaration of Easements, Covenants, Conditions and Restrictions for Brookfield South recorded in Deed Book 1743 at Page 911 in the Greenville County Registry (collectively, hereinafter referred to as the "Declaration); and

WHEREAS, Bank of America, pursuant to Article X, Section 5 of the Declaration, desires to transfer and assign to Brookfield, which has an ownership interest in some portion of the Property (as defined in the Declaration), which has experience in owning, managing or developing similar properties, and which will assume the duties of Declarant pertaining to the particular rights, powers, easements, and reservations assigned, all of the rights, powers, easements, reservations, duties and obligations of Bank of America in its capacity as Declarant under the Declaration;

NOW, THEREFORE, for and in consideration of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America and Brookfield, intending to be legally bound, hereby agree as follows:

- Pursuant to Article X, Section 5 of the Declaration, Bank of America hereby transfers
 and assigns to Brookfield, all of Bank of America's rights, powers, easements,
 reservations, duties and obligations in its capacity as Declarant under the Declaration.
- From and after the date hereof, Brookfield shall possess and be entitled to exercise, and, Brookfield hereby assumes, any and all of the rights, powers, easements, reservations, duties and obligations of Bank of America in its capacity as Declarant under the Declaration.
