SECOND AMENDMENT TO DECLARATION

WHEREAS, the Association approves of the Second Amendment and joins in this Second Amendment to indicate its consent.

NOW, THEREFORE, the Declarant and the Association do hereby publish and declare and agree as follows:

Condominium Unit D as shown on the Map is hereby subdivided as shown on the Revised Map. Exhibit B, which is attached hereto and incorporated herein for all purposes, shall replace the Exhibit B attached to the Declaration.
