FIRST AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS FOR AUSTIN VILLAGE

COUNTY OF UNION

THIS FIRST AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS FOR AUSTIN VILLAGE (the "Amendment") is made this 9th day of August 2011, by AUSTIN VILLAGE, LLC, a North Carolina limited liability company ("Declarant);

## WITNESSETH

WHEREAS, the Declaration of Protective Covenants for Austin Village was recorded in the Union County Public Registry in Book 3529, at Page 718 (the "Declaration"); and

WHEREAS, Section 3 of Article XI of the Declaration provides that the Declaration may be amended by an instrument signed by the Owners of at least fifty-one percent (51%) of the Total Votes and prior written approval of the Declarant, so long as the Declarant still owns any portion of the Property (unless the context otherwise

requires, all defined terms utilized herein shall have the same meaning ascribed to them in the Declaration); and

WHEREAS, Declarant is the owner of a portion of the Properties; and

WHEREAS, Section 3 of Article III of the Declaration provides that notwithstanding any contrary provisions of the Declaration, the Declarant shall be entitled to fifty-one percent (51%) of the Total Votes until January 1, 2015.

NOW, THEREFORE, the undersigned Declarant does hereby amend the third sentence of Section 3 of Article VII as follows:

"Each Owner may install and use underground storage tanks ("USTs") on its Lot or other portion of the Properties owned by such Owner in the ordinary course of its respective business, provided that the use, generation, handling, storage, production, processing and disposal of any Hazardous Substances in connection with such USTs shall not violate, or give rise to any obligation to take remedial or other action under, any applicable Environmental Laws."

Declarant hereby acknowledges and agrees that in all other respects the Declaration shall remain unchanged and in full force and effect and the Declaration, as amended herein, is hereby ratified, affirmed and approved.
